- 6. LATE PAYMENTS Payment of this bill after September 14, 2023 requires an additional \$10 publication fee. For payment options please see our website. The last day to pay is by close of business 4:30 pm on October 25th. Tax Sale will take place at 9 am on October 30, 2023.
